This workshop pushes beyond simply having the right ideas about faith and explores the role of liturgy & worship in shaping our parishioners experience of work as mission. Beginning with our Sunday liturgy and our Book of Common Prayer, our desire is then to empower our laity to write liturgies, prayers, and vocational vows that shape their imaginations to be a "priesthood of all believers" sent to reveal the Kingdom of God in their workplaces.

#### **Serving Basics for LEMs**

The lay servant in sacred liturgy is a ministry of the Christian church that goes back over 2,000 years. From the first, the celebrant of the Liturgy had assistants. As lay ministers, we share in this long, honorable and important tradition of the church. We will review our role in the Liturgy and how it is practiced in the different worship spaces we serve.

#### **Reaching Muslims for Christ**

#### Led by Fr. Matt Walter

As our communities become home to a growing Muslim population, Christians are already interacting with Muslims—at work, at the store, on campus, at the gym, and in their neighborhoods. **The question is no longer if we will engage with Muslims, but how.** Based on his experience here and the Middle East, Fr. Matt, equips believers to share the gospel with Muslims with confidence and humility in love.

# Pastoring the "Spiritually Hungry, Religiously Done": Trauma-Safe Care and Classic Devotion for Faith Reconstruction in Today's Anglican Parish

#### Led by Deacon Preston Hill

Across North America an increasing number of baptized Christians describe themselves as "spiritually hungry but institutionally done." I out of 10 individuals used to identify as religious but no longer do, and explicitly identity church hurt as the reason for leaving organized religion. Many still yearn for prayer, Scripture, and sacramental life even while carrying wounds of church-based harm that complicate their return to congregational worship. Drawing on emerging research into faith deconstruction, religious trauma, and "remixed" spirituality, this workshop equips clergy and laity to shepherd such souls without compromising orthodox Anglican theology.

# Creative Community Outreach: Using What People Already Celebrate to Effectively Reach Them

#### Led by Fr. Justin Clemente

How can you and your parish reach out to the communities around you? Part of the answer may already be there for the taking! This super-practical workshop features real, tested ideas for community outreach. This workshop argues that churches will do well to connect into existing community events (festivals, etc.) with an offering of their own that ties into the event itself. This will lend itself to starting more natural conversations and prayer opportunities.

# Hospital and Homebound Ministry: Raising Lay Leaders to Serve our Suffering and Isolated Church Family

#### Led by Deacon Mikah Alge

Early in our church history we see leaders selected specifically to serve the poor and poor in spirit, forming a partnership within the church to allow those called to teach to teach and those empowered to serve to serve. In any given week, most church families will have at least one, if not

more, members of their church carrying the weight of medical conditions. Whether they carry it themselves or for a loved one, the needs are great, and the capacity of clergy is limited. I invite you to attend this worship not only to learn how to minister to the sick in various contexts but also to discover why clergy should be delegating helpers to fix their physical and spiritual attention on this population of the church. As an experienced hospital chaplain, I will map out ways to identify these leaders in your congregation, train them, care for them, and utilize potentially untapped relationships within your local hospital.

#### Finding Unity: A Case Study in Decision-Making

Led by Fr. Mark Royster

Nine years ago, the vestry at St. Peter's decided to implement the Biblical principle of "Headship and Unity" as described by the Rev. Terry Fulham, Rector of St. Paul's, Darien, Connecticut (the epicenter of the 1980s renewal movement in the Episcopal Church). We have found that it is indeed possible to operate based on total unity in decision-making. God has used this principle to protect us from some blunders and to grow our faith that the Holy Spirit can guide us in every decision.

### Rules of Order

of the Diocesan Synod of the Anglican Diocese of the South



These Rules of Order were adopted by the Diocesan Synod for use at its organizational meeting in Loganville, Georgia on April 30-May 1, 2011, and, since adopted, shall remain in effect for any subsequent and special meetings of the Diocesan Synod until amended or superseded. The purpose of our deliberations, prayer and reflection is, as best as possible, to discern the Will of God.

- 1. Concerning Meetings and the Agenda. Annual meetings shall be scheduled at least eleven (11) months in advance. The Standing Committee shall determine the organization and agenda of any meeting. Any ten (10) Delegates may have an item or items included on the agenda before any general meeting is called to order.
- 2. Concerning the Chair. The Chair of the Standing Committee shall call to order and preside as Chair over the organizational meeting of the Synod. At all subsequent meetings of the Synod the Bishop shall call to order and preside over the meeting as the Chair. The Bishop may designate another presiding officer pro tem to act as Chair or, in the Bishop's absence, the Standing Committee may choose a presiding officer pro tem.
- **3. Concerning Officers and Committees of the Meeting.** The Chair shall appoint a Secretary to keep minutes of the proceedings and a Parliamentarian to advise the Chair on procedure, and such other officers and committees of the meeting as the Chair deems necessary.
- **4. Concerning the Quorum.** The Registrar shall report on the number of Delegates who have registered for the meeting. A quorum for the transaction of business consists of one half of the elected lay Delegates and one half of the clerical Delegates.
- **5. Concerning Prayer.** The business of every meeting shall be introduced with prayer, and a call to prayer shall always be in order, when made by a Delegate entitled to the floor. The Chair shall designate the person(s) to lead in prayer.
- **6. Concerning Order and Decorum.** Order and decorum shall be observed at all times. When the presiding officer takes the Chair, the Delegates shall seat themselves and not afterward stand up, except to address the Chair. The Delegates shall continue in their seats and shall not hold any private discourse while the meeting is in session. When the Synod is about to adjourn or recess, the Delegates shall keep their seats until the presiding officer leaves the Chair.

- 7. Concerning Taking the Floor. Delegates shall rise to be recognized by the Chair. A Delegate arising to speak shall with due respect address the Chair, and shall not address the House or another Delegate except with permission from the Chair. In debate Delegates shall confine themselves strictly to the point in debate. No Delegate shall speak more than twice in the same debate in the same session without specific leave by the Chair.
- **8. Concerning Motions.** No motion shall be put or debated until it is seconded, and, when seconded, shall be stated by the Chair before it is voted on. The Chair or any ten (10) Delegates may have a motion reduced to writing. The report of a committee or task group does not require a motion or second; it shall be deemed to have been moved and seconded.
- **9. Concerning Divisible Propositions.** If a question in debate contains two or more distinct propositions, the Chair may divide them or any Delegate may have them divided.
- 10. Concerning Voting for in-person meetings. Unless otherwise provided in the Constitution or Canons, all matters shall be decided by a majority vote of the Delegates voting either altogether or by orders. Voting by orders shall take place if requested by no less than five (5) Delegates, either lay or clergy, in which case a majority of each order shall be required to carry a decision. All votes on motions at meetings shall first be by voice vote. The Chair shall rule on whether a motion is carried or not. If the Chair is in doubt, or if requested by five (5) Delegates, the Chair shall call for a show of hands. The Chair may request a roll call vote or a written ballot for a final determination of any matter. The Chair may appoint tellers to assist the Secretary in any count. Elections of officers shall be by voice vote unless the Chair determines to call for a written ballot.
- 11. Concerning Procedures for Voting for electronic meetings. The chair has the discretion to conduct voting by either a show of hands or by online ballot. Voting that requires more than one option (ex. nominees for the Standing Committee) must meet the following criteria: The total number of votes cast may not exceed the total number of votes allowed. A round of voting that does not meet both of these criteria will be declared invalid another round of voting will be initiated. Voting by orders shall take place if requested by no less than five (5) Delegates, either lay or clergy, in which case a majority of each order shall be required to carry a decision. All votes on motions at meetings shall first be by a show of hands or online ballot. The Chair shall rule on whether a motion is carried or not. If the Chair is in doubt, or if requested by give (5) Delegates, the Chair shall call for a show of hands or online ballot. The Chair may request a roll call vote for a final determination of any matter.

- **12. Concerning Follow-on Motions.** When a question is under consideration, no motion shall be received unless to:
  - a. lay upon the table,
  - b. postpone indefinitely,
  - c. postpone to a certain time,
  - d. commit to a committee, or
  - e. amend.

Motions for any of these purposes shall have precedence in the order listed above.

- **13. Concerning Motions to Lay on the Table.** A motion to lay on the table shall be decided without debate. If a motion to lay an amendment on the table is carried, the meeting shall proceed as if no such amendment had been offered.
- **14. Concerning Reconsideration.** A question once decided shall not be reconsidered during the same meeting without an affirmative vote of two-thirds of the Delegates present, or without a motion for that purpose being made by one of the majority on the prior decision. No question shall be reconsidered more than once at the same meeting.
- **15. Concerning Procedural Questions.** All questions of order shall be decided by the Chair, subject to being overruled by a vote of the Delegates present at the call of any Delegate. There are no Questions of Privilege or Points of Order; all procedural questions are merged into an appeal of the Chair's decision.
- **16. Concerning Matters Beyond These Rules.** Whenever these Rules fail to provide direction for a particular matter before the Council, the Chair, with advice from the Parliamentarian, shall determine the procedure to be applied.
- **17. Concerning Recesses.** The Chair may at any point call a recess for a time certain of up to one (1) hour. A longer recess may be declared by majority vote of the Delegates present.
- **18. Concerning Motions to Adjourn.** A motion to adjourn shall always be in order and shall be decided without debate.

# #1 CONSTITUTIONAL CHANGE RE: CLERGY ELIGIBILITY FOR VOTING

**Article IV, Section 2(b):** [Now reads]: The clerical delegates to the Synod shall consist of the Bishop or Bishops of the Diocese and all of the presbyters and deacons canonically resident in the Diocese and attached to member Congregations or Missions. No clerical member under ecclesiastical discipline of this Church shall be entitled to a seat in the Synod.

Proposed Changes to: Article IV, Section 2(b): The clergy delegates to the Synod shall consist of the Bishop Diocesan bishop, or Bishops of the Diocese any other assisting bishops in the diocese, and all of the presbyters and deacons canonically resident domiciled in the diocese and attached to member Congregations or Missions ministering in a local congregation. Clergy who are not ministering in a local congregation (ADOTS Parish, ADOTS Mission, or ADOTS approved Plant) and are active in a ministry affirmed by the bishop shall also be eligible to serve as clergy delegates to the Synod. Clergy who are domiciled in another diocese or Anglican jurisdiction but are licensed by the bishop to serve in this diocese are invited to have a seat in the Synod, but no voice or vote. No clerical member under ecclesiastical discipline of this Church shall be entitled to a seat in the Synod.

Article IV, Section 2(b): [Would read]: The clergy delegates to the Synod shall consist of the Diocesan bishop, any other assisting bishops in the diocese, and all presbyters and deacons canonically domiciled in the diocese and ministering in a local congregation. Clergy who are not ministering in a local congregation (ADOTS Parish, ADOTS Mission, or ADOTS approved Plant) and are active in a ministry affirmed by the bishop shall also be eligible to serve as clergy delegates to the Synod. Clergy who are domiciled in another diocese or Anglican jurisdiction but are licensed by the bishop to serve in this diocese are invited to have a seat in the Synod, but no voice or vote. No clerical member under ecclesiastical discipline of this Church shall be entitled to a seat in the Synod.

**Comments:** The changes resolve confusion or ambiguity concerning clergy voting eligibility at Synod and assure that voting clergy are active in ministry in the Diocese. Note that constitutional changes must be approved twice in subsequent annual meetings by a two-thirds (2/3rds) majority of the entire number of delegates eligible to vote at any annual meeting of the Synod. This is the first vote on this amendment.

# #2 CONSTITUTIONAL CHANGE RE: BISHOP ELECTION PROCESS

Article V: The Office of Bishop

#### Section 3: Concerning the Election of Bishops:

Bishops shall be chosen by the Diocese in conformance with the Constitution and Canons of the Diocese and consistent with the Constitution and Canons of the Church. With the consent of the College of Bishops, the Diocese may commence the process of election of a bishop, the election of the Bishop of the Diocese or a Suffragan Bishop or Bishop Coadjutor, or the selection of two to three nominees for Bishop of the Diocese or a Suffragan Bishop or Bishop Coadjutor, which shall take place at the annual meeting or at any special meeting of the Synod called for that purpose.

The vote shall be by secret ballot and by orders. A majority of the votes cast by lay and clerical delegates voting by orders on the same ballot shall be necessary to a choice, whether for election as a Bishop or selection as a nominee. If nominees are being chosen, each delegate may vote for as many as there are nominees to be chosen from a slate which may number more than the nominees to be chosen. The Secretary of the Diocese shall promptly certify the election of a Bishop for consent by the College of Bishops of the Church<del>, or certify two or three nominees</del> from which the College of Bishops may select one for the Diocese, as the case may be. The Standing Committee by majority vote of its members shall determine which procedure shall be employed and, in the event the nominee procedure is employed, shall determine the exact number of nominees to be selected. If the Synod shall find only one suitable candidate for the office of Bishop, the name will be submitted for consideration by the College of Bishops with the permission of the Archbishop of the Church. In the event that the Bishop-elect or the nominees are is rejected by the College of Bishops, another election meeting of the Synod shall promptly be called by the Bishop or the Standing Committee. Upon the consent or choice of a Bishop-elect by the College of Bishops, the Archbishop shall take order for the consecration and/or installation of such Bishop in accordance with the Constitution and Canons of the Church.

**Comments:** These Constitutional changes give additional guidance for the Bishop election process and provides for the election of a Bishop rather than nominees. Note that constitutional changes must be approved twice in subsequent annual meetings by a two-thirds (2/3rds) majority of the entire number of delegates eligible to vote at any annual meeting of the Synod. This is the first vote on this amendment.

As **Canon to the Ordinary**, I serve as the Bishop's chief clergy administrative aide, translating vision and initiatives into the processes necessary for them to achieve fruition. I work with our ministry leaders and am responsible for the ordination process, communications, clergy/parish transitions, and formation, as well as help with diocesan health insurance, and development programs. Below, I've provided a snapshot of my ministry events and trips and completed projects for the calendar year 2025.

**Clergy Formation:** For clergy care, we offered this year deanery meetings and synod gatherings. We have also assisted with counseling and other support to individual clergy as needed. ## 2025 CANON MISSIONER REPORT

The Reverend Canon George Ivey Diocesan Synod Report



- Our shining event this year was the 50th anniversary of the New Wineskins Global Missionary Conference at Ridgecrest, North Carolina, from September 17-20. The pre-conference and the post-conference were rich and meaningful. The theme was "Hope for the Nations". There were over 1,500 participants and 99 presenters. Our mission outreached, multiplied, and connections were made. ADOTS supported this event with a \$30,000 gift.
- The Anglican Global Missions Partners convened at All Saints in Peachtree City on February 24-26. We now have 60 Partners who have joined our team. This is a highly productive team that seeks synergies within our Global Mission Initiative. On June 22-27, Anglican Global Mission Partners convened in Greensburg, Pennsylvania, and invited all our ACNA Bishops to visit us at Christ Church. The attendance was excellent.
- Anglican Frontier Missions convened in Richmond, VA, for a three-day conference designed to seek God for greater global outreach.
- AFM is expanding their budget and the number of cross-cultural workers. They now have just over 50 teams on major unreached mission fields.
- ADOTS has had five cross-cultural workers join our force. Austin White has made a commitment to ministry in Kazakhstan. Abby Hadley will be going to Thailand. Lexi and Hutton Cate will be serving in Indonesia. The Bernardis will serve in Algeria. The Roses will minister in Kazakhstan.
- Promotion continues within ADOTS churches to use World Mission Sunday, February 8, 2026 to emphasize ADOTS' dedication to world Missions.
- Our gold key ADOTS missions' event will take place on November 6, 2025. The ADOTS Mission Roundtable. It begins at 9:30 AM and concludes at 2:30 PM. The Reverend Corina Casas, Executive Director of The Church's Ministry Among the Jewish People. The event will also feature Bishop Cherian, Bishop of Kerala, India.

## 2025 YOUTH & FAMILY MINISTRY REPORT

Lay Canon Jessica Greiner Diocesan Synod Report



It continues to be an honor to serve the Diocese as the Lay Canon for Family and Youth Ministry. This past year has been marked by meaningful collaboration and renewed vision for how we equip and connect those serving children, students, and families across ADOTS. My focus continues to be building strong networks, providing practical resources, and fostering a culture of shared ministry that strengthens the work of discipleship to the next generation.

#### **NETWORKING AND CONFERENCES**

This year provided rich opportunities for learning, collaboration, and inspiration. I attended the Formed Conference as a panelist in Chattanooga, which offered valuable theological insight and practical ideas for ministry amid the rise of technology. I also traveled to Chicago to participate in the Rooted Conference and made meaningful connections with other Anglican leaders in youth, family and children's ministry. This year, I had the privilege of attending the Annual Clergy Retreat, which, for the first time, welcomed clergy families. It was a joy to help design and facilitate a thoughtful program specifically for children. The addition of family participation brought a beautiful sense of community and strengthened the bonds among our clergy and their loved ones. Throughout the year, I also participated in monthly ACNA Family Ministry and Student Ministry Network calls, as well as other topical discussions.

#### RESOURCING MINISTRY LEADERS

Providing practical, theologically and liturgically rich resources for ministry leaders has remained central to my work. I also offered one on one consultations with a number of children's and youth leaders across the diocese—advising on topics such as program structure, curriculum selection, ministry environments, seasonal planning, and safeguarding.

#### INAUGURAL ABIDE YOUTH SUMMER CAMP AT SHOCCO SPRINGS

One of the most exciting milestones this year was hosting the first annual ADOTS Youth Summer Camp at Shocco Springs Conference Center in Alabama. This event marked a significant step forward in building shared community among youth and leaders across the diocese. The camp brought together more than 100 students and leaders across the Diocese for a week of worship and prayer, teaching, small groups, and outdoor fun — all centered on deepening faith and forming connections.

Our incredible leadership team modeled what healthy collaboration and discipleship look like—leading with joy, humility, and encouragement. The atmosphere was one of belonging and unity, where students

could see and feel that they are part of something much bigger than their home parish: a living, growing family of faith across our diocese. I would like to personally thank Courtney Allen from Mission Chattanooga. Her efforts made this first Abide camp a huge success and laid the groundwork for what will become an annual diocesan tradition.

As Coordinator of Life Issues for ADOTS, I encourage every parish to get involved in life affirming ministry if you haven't already.

AFL offers two different levels of involvement as a leader. One individual can serve as a Life Leader, and can later move on into a Chapter Leader role, as your church is able to form a chapter. Both levels need to be prayerfully approached and blessed by the rector.

Our national AFL office, led by Canon Georgette Forney, is an enormous support. She and her team in Ambridge, Pennsylvania are always available to guide you with resource materials and conversations by phone/email. In August, I was asked by Father Phil Hannah, to come to Redeemer Anglican in Chattanooga. After speaking to a small group on Saturday evening, as well as a Sunday School class and an after church meeting, I was extremely encouraged. They have a group which is incredibly enthusiastic about beginning their chapter in 2025!

I also serve as Chapter Leader of the Holy Cross Cathedral Anglicans for Life Chapter. We have had a productive year.

- 1. In March we prayed at a Planned Parenthood facility along with Father Justin Clemente.
- 2. On April 27th, I led a seminar from 2:00-4:00pm entitled "Finishing Life Well." Our chapter promoted the seminar several weeks in advance. We were thrilled to have 40 church members sign up. The purpose was to encouraged every attendee to appoint a Power of Attorney for Health Care instead of a Living Will. We provided each person with POA form, which I explained, along with a copy of AFL's Finishing Life Well Booklet.
- 3. In July our chapter hosted our annual Holy Cross Baby Shower between church services. Church members dropped off their gifts in the church foyer. All gifts go to our local Pregnancy Center.

- 4. In November we will have an AFL table at the Synod Ministry Fair.
- 5. Many of our chapter members work with community outreaches with children, with our church disability team, and pregnancy center.
- 6. We are now planning to survey church members to determine which bioethical topics they want to learn about in 2026.

## 2025 SPIRITUAL DISCERNMENT REPORT

This year the deliverance team ran two trainings for new deliverance teams. One in Atlanta and one in Madison/Huntsville, Al. We were called to help out/consult with deliverance and exorcism issues for churches from each of our deaneries. Our deliverance sessions are gentle process designed to help free a person (or churches) from evil, sins, and/or traumas that are weighing their life down or crushing them. To these issues, frequently various demonic entities attach. This process is a gentle way to remove those as well. We handle cases of all levels from basic deliverance up through severe possession. A typical session lasts 2.5 hours. More substantial cases take more sessions and sessions can run longer. We do not do counseling. It is a prayer process. The diocese would like to thank all of our members for their hard work in this ministry of mercy and compassion for their fellow believers.

Our newly trained team at Good Samaritan had 10 deliverance sessions. Our trainings provide the opportunity for us to pull together trained clergy and parishioners from various parishes to work on cases in other churches. These diocesan teams are sometimes scheduled to come together and sometimes are pulled together at diocesan gatherings at our bishop(s) request. Our diocesan teams handled approximately 11 cases this year. Our senior team had 36+ deliverance sessions from individuals in the diocese, our local area, and several from out areas outside of our diocese. If you are interested in training for your congregation, please contact the diocese.

## 2025 CANON THEOLOGIAN REPORT

If you are a theologian you truly pray. If you truly pray you are a theologian (Evagrius Ponticus (c. 346-399), The 153 Chapters on Prayer, Chapter 60).

Faced with that definition I offer the 2025 annual report praying for my own inadequacies:

Lord have mercy, Christ have mercy. Lord have mercy.

As ADOTS Canon Theologian my work is not in service of the academy but rather of the diocese and its parishes, of its clergy and its people, and, in a wider sense, of all those who might be interested in pastoral reflection and Biblical clarity in the midst of these complex and confusing times. I am available to laity and clergy alike, upon request, as a resource and conversation partner and may be reached at john@apostlesonline.org

In 2025 I authored a few brief papers, some written from personal concern and some written upon request, among them:

"Freemasonry: An Anglican Perspective" which explores the intersection of Freemasonry and Christian faith and practice, specifically addressing whether Freemasonry is compatible with Scripture, Creeds, baptismal vows and identity, and our Anglican formularies. The paper also addresses various pastoral issues at the parish level. This work was requested by and presented to Archbishop Foley.

"The Priesthood of the Laity for Women" which considers the nature of creational and baptismal priesthood and the practice of that vocation both generally and specifically by women in our parishes. This was requested by and presented to Women of the Word, part of the women's ministry at Apostles Anglican Church.

I also continue to post brief theological reflections — often on current issues — on the blog First Blessings (www.firstblessings.blog).

Throughout the year I have discussed various theological and pastoral concerns and issues with both lay and clergy members of our diocese on an as-needed basis.

Additionally I serve as an instructor of theology and spiritual direction at the St Benedict Center for Spiritual Formation (www.stbenedict-csf.org) which prepares spiritual directors for our diocese and beyond.
